

## Christian Life Mentoring/ Marriage Coaching Service Agreement

### **Mentor/Coach Role Defined**

My role is defined as a Mentor/Coach and not a psychotherapist or mental health counselor. While the services I provide can be considered therapeutic and supportive on many levels, they are not meant to replace services offered by a licensed mental health or medical professional. Referrals to license mental health or medical professionals will be provided to each client upon request.

### **Mentor/Coach Responsibilities**

The focus of each session will be to determine elements of your God designed identity, spiritual gifts, and potential ministry paths you are called or led to pursue. Assistance can also be provided to identify and achieve your relational, spiritual, personal, and/or professional goals from a biblical perspective. Spiritual interventions, prayer, and scripture will be used during each session.

Results are attained collaboratively as you pursue your relationship with God through the power of Jesus Christ as led by the Holy Spirit. Factors that impact results are greatly influenced by your investment in spiritual disciplines outside of each session. Session time will be spent in self-exploration through collaborative conversations, construction of meaning from life's circumstances, and discernment of what steps you can take to promote positive changes spiritually, personally, professionally, and relationally. Service delivery options included in this agreement include face-to-face meetings, telephone conversations, text messaging, and email correspondence depending on the needs of the client.

### **Confidentiality**

Personal information or business information supplied by clients in coaching sessions will be treated as confidential. Client information will not be disclosed to a third party without prior permission granted in writing, save where required by law or where action might be necessary to prevent harm to the client or someone else. The client takes responsibility for information provided through electronic media.

### **Cancellations**

Please provide me with at least 24-hour notice if you need to cancel a session. In exceptional circumstances, sessions may need to be rescheduled on my part. I plan to give 24-hours notice if rescheduling is necessary on my part. Emergency cancellations are possible as well due to illness, weather, or problems with the rental facility. I plan to confirm appointments 24-hours prior to the scheduled meeting time.

### **Client Responsibilities**

I am motivated and committed to taking action to achieve my spiritual, personal, relationship goals. I understand that full participation is expected on my part. I accept full responsibility for myself and any actions I take that might result from this coaching relationship. I agree to work through any personal conflicts as it relates to this coaching relationship by conforming to biblical principles for resolution and reconciliation as a fellow member of Christ's family.
